### STAFF REPORT

1. Monthly Highlights – Andrea Klaas provided full report in meeting packet. MIDCO purchased the Windseeker and is now looking for an operator of the restaurant; Bernert Barge is starting to get more work and need to ship loads around. They will be constructing a new breasting dock along their current location; USP did clean up their landscaping. Riverside Gymnastics is supposed to be taking care of theirs but so far no progress. I will be sending Miyong Limmeroth a certified letter listing our remedies. Also talked to EverSummer about their landscaping. They have traded use of their vacant lot for parking FLI landscaping to clean up their site. If there is not substantial progress next week they will also be getting a letter; Pierce from DirtHugger reported they finished removing the last of the material from Port

property. He extended an invitation to all of you to come see their new site; two more transformers have arrived; BPA is moving ahead with installing utilities; Crestline has scheduled a walk-through of the project on June 4 at 2pm if you would like to join us; new phone system at the office with a live person answering every call; developing a list of folks to visit in Portland, businesses, developers, site selectors, etc., will be bring a box of fresh The Dalles cherries to each; Columbia Gorge Industrial Certified Site process is kicking back into gear. Trying to get the site included in the next evaluation window which will be before the end of June, 2015.

- 2. Marketing & Communications Update: Kathy Ursprung provided full report in meeting packet. Land Marketing Continue to market the CGIC to targeted sectors; advertising in Capital Press; recurring ads in the Gorge Magazine; also ad in Trade, Industry and Development; promo video on the port and airport lands that tie together life-style with business advantages; July 31, 2015 set for dedication event. Wetland Regional General Permit May 18, 2015 TAC toured the wet-lands of the study area; participants received specific information about potential mitigation sites. TAC will meet on July 7, 2015 to begin negotiation process between parties involved; estimate that we should be able to submit the final applications to the DSL and COE by end of 2015.
- 3. Marina Update: Kathy Norton provided report in meeting packet. 2015-16 moorage leases to go out soon; 2015-16 marina project will be to replace the electric power poles; exploring options for locating new port boathouse; following the April meeting I was reminded that there was a waiting list and the first name on that list was Deric Anthony. Past Port policy was to follow the waiting list when it came to marina usage.

Motion to approve following existing Port policy to use the waiting list for marina usage. M/K.McCavic, S/M.Courtney, motion approved unanimously.

Main Street – June 2, 2015 meeting included a discussion on ways to engage downtown businesses/building owners in process, funding sources for Main St, and updates from committees.
