1. Resolution #2013-005/Authorizing Port Representation as part of International Trade Mission:

Motion to approve Resolution #2013-005 Authorizing Port Representation as part of International Trade Mission. M/M.Courtney, S/D.Griffith. Motion approved unanimously.

- Vertical Housing Zone: Andrea Klaas reported that the City of The Dalles recently approved Resolution #13-027 adopting a vertical housing zone in the central business district. The Commissioners requested Andrea have Dick Gassman attend the September to provide more information on taxing dollars.
- 3. Monthly Highlights Andrea Klaas reported that she attended the Oregon Economic Development Association Summer conference in Corvallis. The conference focus was on International Trade, OSU Advantage program and food processing; met with Ron Schmidt and Brian Goodwin to talk about Project Endeavor; met with Mary Merrill and a representative for a company that invests in regions where New Market Tax Credits exist which is a large portion of



The Dalles; Commissioner McFadden, Michael and Andrea met with Ray Buhager, the Oregon Port's lobbyist. Issues presented to him were, wetlands that have Federal oversight; flowage easements; FEMA mapping and Scenic Area funding.

- 4. Development Update: Michael Held reported no big changes to North Chenoweth progress. PUD plans received and a meeting with all utilities has been scheduled for 8/15/2013. Bid documents in process, Bids expected to go out by end of August; Quarterly newsletter from the Port will start going out in September. Newsletter to be distributed widely electronically with targeted mailings; 30-60 second video spots on Port's available properties will be prominently featured on website, Facebook, Twitter, Youtube, etc.; upgrading our membership affiliation with Loopnet.com to allow our properties to be seen by anyone accessing the site; Wetlands update-OIB grant submitted, Tech Advisory Committee meeting in September, meeting with property owners to determine their financial commitment. Dept. of State lands has been a tremendous partner to the Port enabling us to engage in such a proactive effort in addressing wetland issues; participated on the interview committee to place a new RARE planner with The Dalles Main Street. The Dalles Main Street, MCEDD and the Housing Authority all received their first choices.
- 5. Marina Update: Kathy Norton updated the Commission on activities at the Marina; Sea lion still an issue. Will meet with a representative from the Marine Mammals Stranding Network on 8/17/2013 so she can assess the situation; the mechanical locking system for the west Marina gate has been installed and seems to be working well; guest moorage power appears to be up and running for credit card payments.
- 6. Reports of Committees:
 - a)Urban Renewal Commissioner Weast: Last meeting cancelled
 - b)Chamber of Commerce Commissioner McFadden: Chamber continues to move forward. The car show was great success, new entries and participants filled the local hotels.
 - c)Wasco EDC A.Klaas: Met with Wasco County Planning to look at commercial/industrial property outside the incorporated areas; discussions on what would it take to implement Destination Resort zoning; and discussion on economic impact of festivals in Wasco County.
 - d)Community Outreach Team A.Klaas/Commissioner Weast/Commissioner McFadden: Final meeting last Friday. Meeting scheduled with Oregon and Washington delegations for discussion on policies, urban growth/Scenic Area and flowage easement.
